**Turn-Around Time (TAT) indicates the time from receipt of the sample in the laboratory to the final report and does not include shipping time to the San Joaquin County Public Health Laboratory. All TAT estimates are based on the normal business days: Monday through Friday. Any test requiring supplemental testing by another reference laboratory will increase the stated TAT.**
